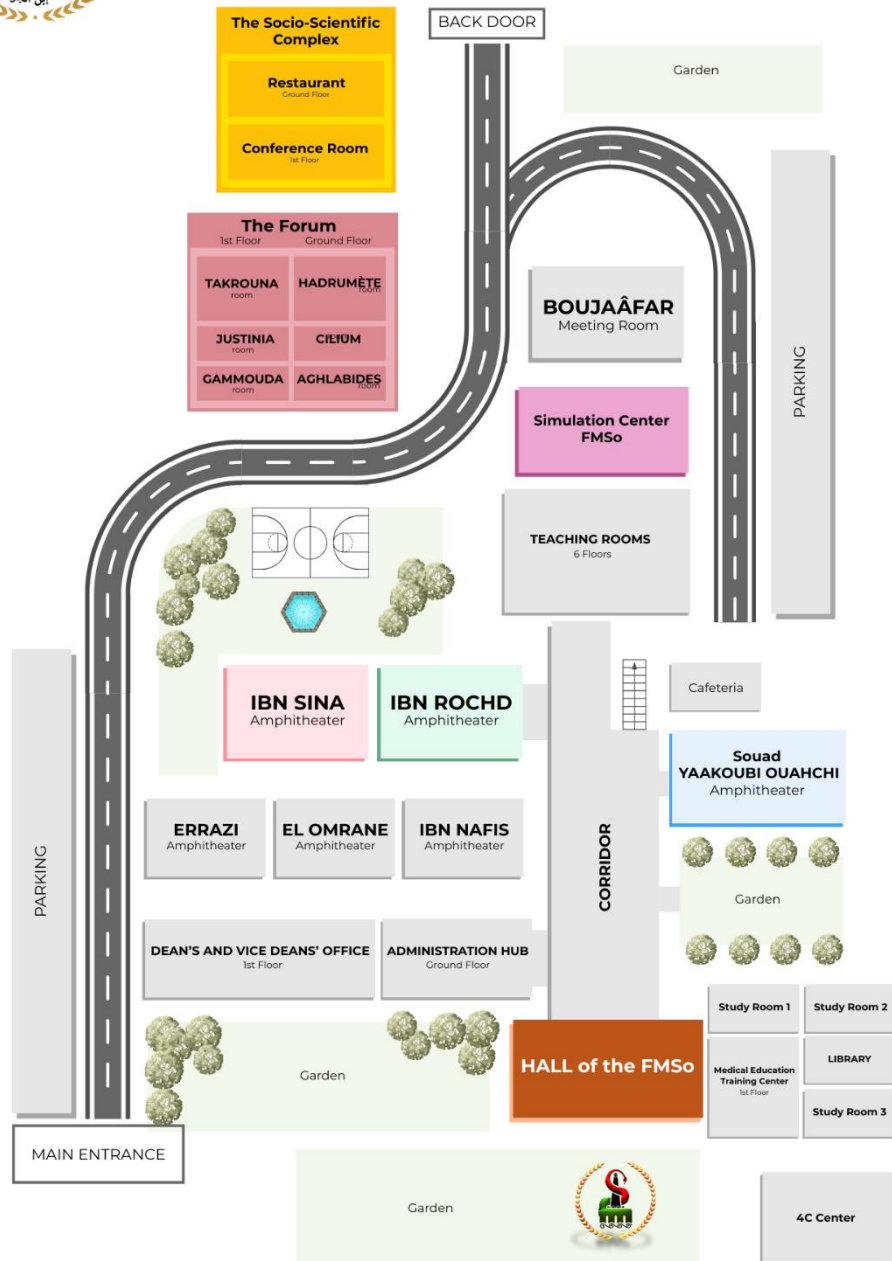

North Africa has high diabetes and CVD rates, while Southern Africa faces obesity and hypertension. Key risk factors include unhealthy diets, inactivity, tobacco use, and pollution. Limited healthcare and data hinder prevention. Community interventions, policy reforms, and awareness are essential to address NCDs, requiring collaboration among governments, NGOs, and international partners.

The talk will showcase Michigan's efforts to enhance population health through innovative, place-based service delivery, highlighting a cross-sector initiative that established a mobile health infrastructure national model.

Alzheimer's Disease Risk and Resilience: The Case of Arab Americans

Alzheimer's disease (AD) is a growing concern for older adults, their families and healthcare providers as populations experience longer life expectancies. Arab ancestry groups living in the United States have largely been invisible in aging research generally, and AD research specifically. This presentation will introduce the Detroit-Aging and Memory Project (D-AMP), the very first data collection meant to assess prevalence levels of dementia and mild cognitive impairment among those of Arab ancestry aged 65 years and above living in metro-Detroit, home to the largest most visible concentration of Arab Americans in the United States. This project investigates the role of immigrant factors and social experiences to better understand AD risk and resilience and provides key information to inform knowledge about health disparities and better develop intervention strategies for effective management of this growing and high-cost disease.

Mental Health Disorders and Mental Health Promotion in Africa Session Summary

Mental disorders impact over 116 million people in Africa, including 10–20% of children. Approximately 85% of those with depression in low-income areas receive no treatment, while Africa has only 1.4 mental health workers per 100,000 people. With 970 million globally affected, youth in sub-Saharan Africa show high rates of depression 26.9%, anxiety 29.8%, and suicidal thoughts 20.8%. Key risk factors include poverty and stigma. Emerging strategies involve community-based interventions, primary care integration, and digital health innovations, emphasizing the need for improved policies and training.

Innovations include portable monitoring, virtual care centers, integrated mobile teams, AI for data analysis, and point-of-care diagnostics, making acute care more accessible and patient-centered than traditional inpatient settings.

This workshop addresses how a skilled public health workforce enhances health system resilience, particularly in MENA, focusing on WHO's Roadmap for National Workforce Capacity in Essential Public Health Functions (EPHFs). The workshop will examine key public health challenges and expectations in MENA, with particular attention to the relevance of EPHFs in areas experiencing conflict. Participants will explore strategies for implementing the Roadmap in the MENA context, learning from case studies of successful EPHF-integrated teaching. 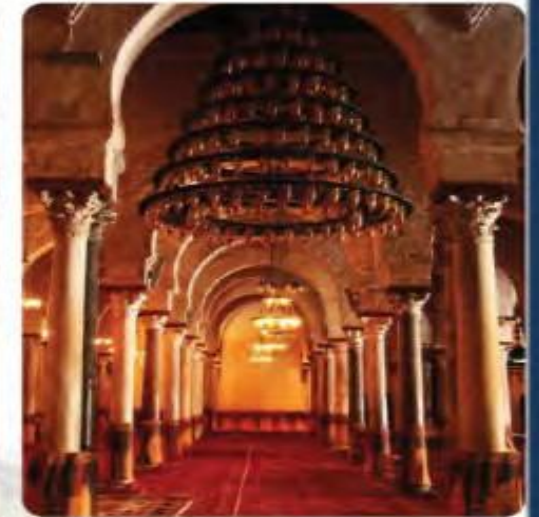
